Complete each row in column B. The tax rate can be in either decimal or percentage format (default). The total amount needs to be in currency or accounting format.	<a href="#">Subchapter A, Chapter 351, of the State's Tax Code</a>
<a href="#">A12:B18</a>	Table requests the total amount of revenue allocated to certain non-population bracketed beneficiaries of revenue during the preceding fiscal year. Do not include allocations of revenue collected by the municipality prior to the most recently completed fiscal year (even if an allocation of such revenue occurred during the most recently completed fiscal year). <a href="#">A20:B26</a>	Table requests the percentage of total HOT revenue allocated to certain non-population bracketed beneficiaries of revenue during the preceding fiscal year.	Complete each row in column B. This can be done formulaically by dividing each row of column B in table A12:B18 by the overall total in cell B10. <a href="#">A28:B30</a>	Table requests the tax rate and total amount of revenue generated from the municipality's sports and community venue tax authorized under Subchapter H, Chapter 334, Local Government Code during the preceding fiscal year, if applicable.	Complete each row in column B. The tax rate can be in either decimal or percentage format (default). The total amount needs to be in currency or accounting format.
